



THE ANNUAL BUDGET AND APPROPRIATION BILL OF WICOMICO COUNTY, MARYLAND TO ADOPT THE COUNTY BUDGET, CONSISTING OF THE CURRENT EXPENSE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2008, THE CAPITAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2008, THE GOVERNMENTAL AND ENTERPRISE FUNDS BUDGETS FOR THE FISCAL YEAR ENDING JUNE 30, 2008; AND TO APPROPRIATE FUNDS FOR ALL EXPENDITURES FOR THE FISCAL YEAR BEGINNING JULY 1, 2007, AND ENDING JUNE 30, 2008, AS HEREINAFTER INDICATED.

WHEREAS, pursuant to Article VII of the Wicomico County Charter, the County Executive has prepared and submitted to the County Council a proposed budget for Wicomico County for Fiscal Year 2008; and

WHEREAS, the County Council has complied with all requirements of the Wicomico County Charter, and has made revisions to the proposed budget as it considers proper.

SECTION 1. BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION that the current expense budget for the fiscal year ending June 30, 2008 is hereby approved and finally adopted for such fiscal year; and funds for all expenditures for the purposes specified in the current expense budget beginning July 1, 2007 and ending June 30, 2008 are hereby appropriated in the amounts hereinafter specified to and for the purposes hereinafter indicated as follows:

Current expense budget WITH APPENDIX "A" TITLED "BOARD OF EDUCATION BUDGET BY CATEGORY" attached hereto as Exhibit A, AMENDED AS SHOWN ON EXHIBIT A-1.

SECTION 1-1. BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION that the capital budget for the fiscal year ending June 30, 2008 is hereby approved and finally adopted for such fiscal year in the amounts hereinafter specified to and for the purposes hereinafter indicated as follows:

Capital Budget for Fiscal Year 2008 is attached hereto as Exhibit A-2

SECTION 2. AND BE IT FURTHER ENACTED AND ORDAINED, that the Governmental and Enterprise Funds Budgets for the fiscal year ending June 30, 2008 are hereby approved and adopted for such fiscal year; and funds for all expenditures for the purposes specified in the

Governmental and Enterprise Funds Budgets beginning July 1, 2007, and ending June 30, 2008, are hereby appropriated in the amounts hereinafter specified for the purposes hereinafter indicated as follows:

Governmental and Enterprise Funds Budgets are attached hereto as Exhibit B AMENDED AS SHOWN ON EXHIBIT B-1.

SECTION 3. AND BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that subject to the laws of Maryland, the Wicomico County Charter, and the Wicomico County Code relating to budgetary and fiscal procedures, the amounts specified are approved, appropriated, and authorized to be disbursed for the purposes specified and in the sums itemized for the fiscal year beginning July 1, 2007 and ending June 30, 2008.

SECTION 4. AND BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION that this Act shall be known as the Annual Budget and Appropriation Bill of Wicomico County.

SECTION 5. AND BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION that the County Budget as finally adopted by this Act shall take effect on July 1, 2007


