LEGISLATIVE BILL 2018-05

AMENDMENT NO. 1

INTRODUCED: October 30, 2018

Introduced by: The President of the Council at the request of the County Executive

AN ACT TO AMEND AND TRANSFER THE APPROPRIATION FROM USE OF PRIOR YEAR FUNDS ACCOUNT TO THE TRANSFER TO OTHERS ACCOUNT IN THE AMOUNT OF \$254,758.15 IN THE ANNUAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2019.

WHEREAS, on June 14, 2018, the County Council enacted Legislative Bill No. 2018-05, the Annual Budget and Appropriation Bill, adopting the Operating Budget for the fiscal year ending June 30, 2019; and

WHEREAS, the Recreation, Parks & Tourism Department is requesting a transfer of funds to pay grant matching funds for the Pirates Wharf project; and

WHEREAS, the Director of Finance has certified that the appropriation to be transferred is not encumbered and funds are available for transfer.

SECTION I: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that "The Annual Budget and Appropriation Bill," be and is hereby amended as follows:

1. Transfer from Account: Use of Prior Year Funds Account– 60A0660-421110 – (\$254,758.15);
2. Transfer to Account: Transfer to Others Account– 60070060-520260 - \$254,758.15.

SECTION II: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that subject to the laws of Maryland, the Wicomico County Charter, and the Wicomico County Code relating to budgetary and fiscal procedures, the accounts are amended to reflect a transfer to pay grant matching funds for the fiscal year beginning July 1, 2018, and ending June 30, 2019.

SECTION III: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION THAT this bill shall be known as Legislative Bill No. 2018-5 – Amendment No. 1 and shall take effect sixty (60) days after its enactment.



Introduced and read first time on October 30, 2018. Ordered posted and public hearing scheduled for November 20, 2018 at 10:00 a.m.






