LEGISLATIVE BILL 2019-01

Introduced: March 19, 2019

AN ACT to amend Chapter 141 of the Wicomico County Code, titled “Fees,” Section 141-2, titled “Dogs” to include a breeder license and administrative fee and to update the County Code cross-reference sections for rabies vaccination, rabies tags and dog licenses.

WHEREAS, Legislative Bill 2018-09, adopted by the Wicomico County Council on October 16, 2018, repealed Chapter 133 of the County Code titled “Dogs and Other Animals” and replaced it with a new Chapter 133 titled “Animal Control”; and

WHEREAS, Chapter 133 of the County Code, Section 133-24, now provides for a breeder license and an administrative fee to be determined by the County Council; and

WHEREAS, the County Council desires to update the cross-reference sections shown in Section 141-2 for rabies vaccination, rabies tags and dog licenses to the current section numbers provided in Chapter 133 of the County Code, and to establish an administrative fee for a breeder license.

SECTION I; BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that Chapter 141 of the Wicomico County Code, titled “Fees,” Section 141-2 titled “Dogs” is hereby amended as follows:

CHAPTER 141. FEES

SECTION 141-2 ~~DOGS~~ ANIMALS.

- A. ~~Imposition of fee.~~ RABIES CLINIC. Pursuant to the authority of ~~§ 133-3B of Chapter 133,~~†The fee for vaccination at the Rabies Clinic OFFERED BY THE HEALTH DEPARTMENT PURSUANT TO SECTION 133-3A(2) shall be \$10 for each animal vaccinated.
- B. Rabies tags. The cost of the rabies tag provided by the animal control authority pursuant to § 133-3EA(3) OR A REPLACEMENT TAG PURSUANT TO SECTION 134-C shall be \$3.

C. Dog licenses. The cost of a dog license for Wicomico County ISSUED IN THE COURSE OF AN RABIES VACCINATION shall be \$0. An Administrative fee of \$13 shall be payable for all dog licenses issued by the animal control authority as provided by ~~Chapter 133, §~~ SECTION 133-4DA.

D. BREEDER LICENSE. THE COST OF A BREEDER LICENSE SHALL BE \$50. AN ADMINISTRATIVE FEE OF \$50 SHALL BE PAYABLE FOR ALL BREEDER LICENSES ISSUED BY THE ANIMAL CONTROL AUTHORITY AS PROVIDED BY SECTION 133-24B.

SECTION II: BE IT FURTHER ENACTED THAT this Legislative bill will be known as Legislative Bill No. 2019-01 of Wicomico County, Maryland and will take effect 60 days after its final passage, unless a timely petition for referendum is filed. If a timely petition is filed, then the bill will not take effect until 30 days after the approval of this bill by a majority of the qualified voters of the County voting in the referendum.


