AN ACT to amend the "Schedule of Fines" adopted by the County Council of Wicomico County pursuant to Chapter 179 of the Code of Wicomico County, entitled "Parks, Recreational Facilities and Areas" Section 179-13, entitled "Violations and Penalties" to increase the fines for violating provisions of Chapter 179.

PREAMBLE

Chapter 179 of the Code of Wicomico County, entitled "Parks, Recreational Facilities and Areas" Section 179-13, entitled "Violations and Penalties" provides that the County Council may establish a schedule of fines for violations of the provisions of the Chapter.

Upon the recommendation of the Wicomico Recreation Commission, the County Executive has determined it advisable to recommend to the County Council the amendment of the Schedule of Fines.

SECTION I. BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that the "Schedule of Fines," adopted pursuant to Chapter 179, of the Code of Wicomico County, Maryland, entitled "Parks, Recreation Facilities and Areas," be amended as follows:



SECTION II. BE IT FURTHER ENACTED THAT this Bill shall be known as Bill No. 2008-1 of Wicomico County, Maryland and shall take effect sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.






