LEGISLATIVE BILL 2020-06

INTRODUCED BY: The President of the Council at the request of the County Executive.

AN ACT TO AMEND THE 2020 OPERATING AND CAPITAL BUDGET TO INCREASE THE WICOMICO YOUTH AND CIVIC CENTER BUDGET IN THE AMOUNT OF \$530,000 BY TRANSFERRING \$200,000 FROM THE RECREATION AND PARKS PRIOR YEAR FUNDS BALANCE; BY TRANSFERRING \$75,000 FROM THE RECREATION AND PARKS CURRENT YEAR BUDGET SAVINGS; AND BY TRANSFERRING \$255,000 FROM THE GENERAL FUND CONTINGENCY.

WHEREAS, on June 4, 2019, the County Council enacted Legislative Bill No. 2019-04 to adopt the County Operating and Capital Budget for fiscal year 2020; and

WHEREAS, the Wicomico Youth and Civic Center is experiencing revenue shortfalls and Wicomico Youth and Civic Center is recommending the following supplemental appropriations as amendments to the 2020 Operating and Capital Budget by increasing the budget for the Wicomico Youth and Civic Center in the amount of \$530,000 from the Recreation and Parks prior year funds balance in the amount of \$200,000, the current year budget savings from Recreation and Parks in the amount of \$75,000, and a General Fund Contingency transfer of \$255,000; and

WHEREAS, the County Executive certifies that the appropriations to be transferred are not encumbered and the funds are available for transfer.

SECTION I: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that the Operating Budget for the fiscal year ending June 30, 2020, is hereby amended as follows:

SECTION II: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that the 2020 Operating and Capital Budget for the fiscal year ending June 30, 2020, is hereby amended to include the changes recited in Section 1 above.

SECTION III: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that subject to the laws of Maryland, Wicomico County Charter, and the Wicomico County Code related to budgetary and fiscal procedures, the amounts specified above are approved, appropriated, and authorized to be disbursed for the purposes specified in the sums itemized for the fiscal year beginning July 1, 2019, and ending June 30, 2020.

SECTION IV: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION THAT this bill shall be known as Legislative Bill No. 2020-06 and shall take effect sixty (60) days after its final passage



INTRODUCED BY: The County Council President


Bill No. 2020-06: AN ACT to amend the 2020 Operating and Capital Budget to increase the Wicomico Youth and Civic Center Budget in the amount of \$530,000 by transferring \$200,000 from the Recreation and Parks prior year funds balance; by transferring \$75,000 from the Recreation and Parks current year budget savings; and by transferring \$255,000 from the General Fund Contingency.
